

# Thank You to Our Cove Community

The Historic Beach Cottages at Crystal Cove date back to the 1920s, when a community of visitors built beachside residences that would be enjoyed for generations. In 1979, the land that is now Crystal Cove State Park, then owned by the Irvine Company, was sold to California State Parks and National Register of Historic Places status was secured for the entire Historic District. Today, the Crystal Cove beach cottages are the last remaining intact example of the vernacular architecture style that was prevalent in California's early 20th century beach communities, allowing visitors to step back into a bygone era. The restoration of the cottages and our work in education and the environment would not be possible without you – the individual supporters, the families and family foundations, our neighbors and our friends.
